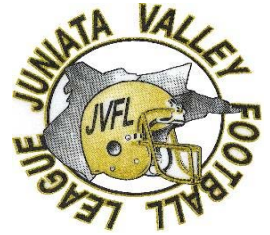


## JUNIATA VALLEY FOOTBALL LEAGUE

League Meeting Minutes, 19 October 2005 & 16 November 2005, Terrace Community Building



### OLD ISSUES :

2005 Playoffs were scheduled, Super Bowl and Punt, Pass & Kick assignments were determined.

Senior Bowl Rosters were collected. Any players that signed up to participate, and are a no show, the team that they are originally from will be obligated to reimburse the League for the cost of the medal. The Belltown coaching staff will coach the East Team, and will practice Monday thru Thursday at Rec Park from 6 - 8pm.
